परिपत्र /CIRCULAR

विषय: कोविड-19 महामारी आपदा प्रबंधन एवं कन्टेन्मेंट के लिए निर्देश।
Sub: Directions for Containment and Management of Covid-19 Epidemic Disaster.

In continuation to this Directorate's earlier Circulars, all employees/residents/ shopkeepers of Anushaktinagar and DAE colonies in Mumbai are required to adhere to the following guidelines issued by Govt. of Maharashtra under Ref.No.DMU/2020/CR.92/DisM-1 dated 4th June 2021 issued by Department of Revenue and Forest, Disaster Management, Relief and Rehabilitation, Mantralaya, Mumbai and Break the Chain Guidelines w.e.f. 7th June 2021 issued by Brihanmumbai Mahanagarपालिका on the above subject :

1) Shop, Markets:-

- Essential Items: All shops dealing with essential items to operate till 4 PM on all days. Medicals and Chemists are permitted to remain operations 24 hours throughout the week/all days.
- Non-essential items: All shops dealing with non-essential items to operate till 4 PM on weekdays.

2) Restaurants: To operate at 50% capacity for dining In; till 4 PM only on weekdays. Thereafter, only Parcel/Take Away and Home Delivery allowed.

3) Public places/Open grounds/Walk/Cycling: Allowed from 5 am to 9 am.

4) Sports : Allowed from 5 am to 9 am/6 pm to 9 pm. Only Outdoor sports.

5) Gatherings (Social/Cultural/Entertainment):

25 people allowed till 4 pm on weekdays. Permission for erecting Mandaps will not be granted for the said gatherings.

6) Marriages :

Will be allowed with maximum of 50 people.

7) Funerals :

Funerals to be attended with a maximum of 20 people.

8) Meetings/Elections- GB of local bodies/co-operative bodies :

Maximum upto 25 people allowed

9) Salons/Beauty Centres : Allowed to operate at 50% capacity (i.e. no. of chairs available) with prior appointments till 4 pm. No Air conditioners to be used inside the Salons/Beauty Centres. A register to be maintained with regard to the appointments.

Note: Wherever it is mentioned that an establishment shall be open till 4 pm it is expected that persons working there or taking a service from that shall reach their homes by 5 pm and there shall be no movements for reasons of either working in these or taking services from these establishments post 5 pm.

CSO, Anushaktinagar may ensure that the restrictions are followed by the employees/residents/shopkeepers. Co-operation of all employees/residents/shopkeepers of Anushaktinagar and DAE Colonies in Mumbai is solicited for effective implementation of the guidelines issued by Govt. of Maharashtra and Brihanmumbai Mahanagarpalika.
