### PART-A: INSTRUCTION FOR ONLINE SUBMISSION

1.	The intending bidders must read the terms and conditions of the tender documents. He should only submit bids if he consider himself eligible and he is in possession of all documents required.			
2.	The information and instruction for bidders along with technical bid and financial bids etc. are posted on website shall form part of the bid document.			
3.	The documents as uploaded in website can be viewed and downloaded free of cost by any one including the intending bidder. However for participating in tendering process the intending bidder must download excel sheets both technical and financial after confirmation of payment towards processing fees, otherwise it will not be possible for them to upload the documents on the e-tendering portal.
