3	Earnest Money Deposit (EMD)	EMD of Rs.1,70,000/- to be submitted in the form of Fixed Deposit Receipt issued by a Scheduled bank in favour of Pay & Accounts Officer, DCSEM, Payable at Mumbai. However the bidders may submit the EMD as follows: i) Rs.85,000/- in the form of Fixed Deposit Receipt as prescribed above. and ii) Rs.85,000/- in the form of Bank Guarantee (BG) issued by any Scheduled bank, drawn in favour of Pay & Accounts Officer, DCSEM, Mumbai. Note: 1) Bank Guarantee not strictly in accordance with the prescribed format shall not be accepted. 2) EMD in the form of cheque will not be accepted.

1	Contractors who fulfil the following requirements shall ONLY be eligible to apply. (Joint ventures are not accepted).
A	Proof of registration with Government / Semi Government organizations like CPWD, MES, BSNL, Railways, State PWDs etc. in appropriate class OR having experience in execution of similar nature of works.
B	Should have satisfactorily completed works during the last seven years ending previous day of last date of submission of tenders. For this purpose cost of work shall mean gross value the completed work. This should be certified by an officer not below the rank of Executive Engineer/ Project Manger or equivalent.
i)	Three similar works each costing not less than Rs. 34.00 LAKHS each , or Two similar works each costing not less than Rs. 51.00 LAKHS each , or One similar work costing not less than Rs. 68.00 LAKHS. AND
	Similar work shall mean: Providing qualified Technical Supervision assistance for various construction projects/ Project Management consultancy for various construction projects.
Note:	The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum ; calculated from the date of completion to last date of submission of tender.
C	Should have had average annual financial turnover of Rs. 85.00 LAKHS on construction works during the last three years ending 31st March, 2016. (Scanned copy of Certificate from CA to be uploaded)
D	Should not have incurred any loss in more than two years during the last five years ending 31st March, 2016.
E	Should have a solvency of Rs. 34.00 LAKHS.
F	List of works in hand & similar works carried out by them for last 7 years indicating i) Agency for whom executed, ii) Value of work, iii) Completion time as stipulated and actual, or present position of the work.
G	List of Technical staff they possess.

I	UNDERTAKING as under:- I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in DAE in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee. (Scanned copy to be uploaded at the time of submission of bid).
2	The intending bidder must read the terms and conditions as per NOTICE INVITING TENDERS of Technical Bid carefully. He should only submit his bid if he consider himself eligible and he is in possession of all the documents required. Department reserves the right of Non-consideration of Tender documents of the agencies who are not fulfilling the NIT stipulations and / or having adverse report on the works carried out by them in the past.
3	Information and Instructions for tenderers posted on website shall form of tender document.
4	The tender document consisting of specifications, the schedule of quantities of various types of items to be executed and the set of terms to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/DAE or www.dcsem.gov.in free of cost.
5	The bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft or Pay order or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards cost of tender document and EMD in favour of “PAY & ACCOUNTS OFFICER, DCSEM, MUMBAI” and Processing Fee in favour of “ITI LIMITED, NEW DELHI, THROUGH E-PAYMENT” and other documents as specified.
6	Those contractors not registered on the website mentioned above, are required to get registered. If needed, they can be imparted training for online bidding process as per details available on the website.

7	The intending bidder must have valid class-III digital signature to submit the bid.
8	On opening date, the contractor can login and see the bid opening process.
9	Certificate of Financial Turn Over: At the time of submission of bid, contractor may upload Undertaking / Certificate from CA mentioning Financial Turnover of last 3 years or for the period as specified in the bid document and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.
10	Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in YELLOW colour and the moment rate is entered, it turns SKY BLUE . In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0" . Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
11	In the case of bids in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
12	The Department reserves the right to accept / reject any prospective application without assigning any reason thereof.
	Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical Evaluation Committee of experts, constituted by DCSEM
13	IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in DCSEM.

PROSPECTIVE AGENCIES SHALL SATISFY THEMSELVES OF FULFILLING ALL THE NIT CRITERIA BEFORE SUBMISSION OF TENDER. DEPARTMENT RESERVES THE RIGHT OF NON CONSIDERATION OF TENDER OF THE AGENCIES NOT FULFILLING THE STIPULATED CRITERIA.
