- i) Name of Work : Maintenance of Fire system (dry Riser) at Zerlina (stilt +12 floors) & Purnima (stilt +14 floors) buildings under LGR Maintenance Unit, Mumbai.
- ii) Estimated Cost : Rs.2,70,000.
