

Salient features of the Direct Recruitment Process for filling up of the post of Assistant Security Officer/A in the Level 6 of the Pay Matrix in Directorate of Construction, Services & Estate Management against Advertisement No. DCSEM/01/2018.

Advertisement was issued for the post of Assistant Security Officer/A (ASO/A) (5 posts – UR) in this Directorate. According to the Recruitment Rules for the post, selection will be based on qualifying in the Physical test, written test and interview. In terms of DAE Office Memorandum dated 20.07.2016, interview has been discontinued for recruitment to Group B (Non-Gazetted) and Group C categories of posts. Therefore, no interview was held for recruitment to the post of ASO/A, being a Group B (Non-Gazetted) post.

Selection for the post of ASO/A was held in two stages as given below.
Stage-I (Physical Test) for selection to the post of ASO/A was held from 3rd – 7th December, 2018 at PTAA facility, Anushaktinagar. Candidates qualified in the physical test were called for Stage-II (Written test) on 13.01.2019 (Sunday) at HBNI, Anushaktinagar.

The Selection Committee met on 22.03.2019 and it was decided to initiate document verification of the first ten candidates before preparation of the select list. Accordingly, document verification was completed as per the requirement.

Statement of marks scored by the 130 candidates who attended the written test for selection to the post of ASO/A, was published on the DCSEM website on 08.04.2019. The Selection Committee empanelled ten candidates in its meeting on 26.04.2019. This select list was published on the DCSEM website on 06.05.2019.

In the meanwhile, two candidates, viz., Shri Rohan B. Dhamane and Shri Vishal S. Patil, sent RTI applications requesting for copies of question paper and answer sheets, and also filed an OA No. 244 / 2019 in the Central Administrative Tribunal, Mumbai bench, citing irregularities in the examination process.

In order to check and verify the correctness of marks awarded in Part A, B and C of the answer sheets of all 130 candidates, a committee was constituted in the Directorate vide Office Order dated 16.05.2019. The Committee, after verifying totalling of marks of Part A and B, found discrepancies in the marks of some candidates.

The bench heard the case on 03.06.2019 and 04.06.2019 and vide Order dated 03.07.2019, has directed the following.

1. To omit two incorrect objective questions (Question No. 1 and 2) of Part-C.
2. To verify if any other questions in the objective type paper are incorrectly framed or correct choices not provided among the 4 alternatives mentioned and then to re-evaluate the objective type answers to arrive at the final select list.

The directions of the Court were complied with, in addition to rechecking of totaling of marks, and a final mark list has been arrived at, which was published on the DCSEM website on 01.08.2019.

Accordingly, the list of selected and empanelled candidates for the post of Assistant Security Officer/A is given below. This list supersedes the list published on the website on 06.05.2019.

* In the case of candidates having identical marks, their names have been arranged in the order of their date of birth, whichever is earlier.

Note:

1. The selected candidates should note that the panel is provisional and does not confer on him/her any right to appointment unless he/she satisfies the Recruitment Norms as per the advertisement and pass the prescribed medical examination. If it is found that any candidate is not fulfilling the Recruitment Rules/Norms, his/her candidature is liable to be terminated/cancelled at any time.
2. The wait list shall be operated only in the event of occurrence of a vacancy caused by non-joining of the candidate from the select list within the stipulated time allowed for joining the post or where a candidate joins the post but resigns or dies within a period of one year from the date of joining, if a fresh panel is not available by that time. Wait list shall however, not be operated beyond one year or after notifying any such recruitment whichever is earlier.
3. The appointments will be subject to availability of vacancies and other related Govt. orders (viz. satisfactory completion of verification of Character & Antecedents (C&A) and Caste and creamy layer status for OBC.
4. Records of the candidates not selected shall not be preserved beyond 6 months from the date of publication of select panel.
5. While every care has been taken in preparing the result, this Directorate reserves the right to rectify errors and omissions (if any).
