

**Salient features of the Direct Recruitment Process for filling up of the post of Technician/B in the Level 3 of the Pay Matrix in Directorate of Construction, Services & Estate Management against Advertisement No. DCSEM/01/2018.**

An advertisement was issued for the post of Technician/B for 14 posts (UR-6 / OBC-8) in six disciplines, vide Advt. No. DCSEM/01/2018. As per the methodology for selection to the post, selection has to be made in 3 stages (Stage-I-Preliminary Test / Stage-II-Advanced Test / Stage-III-Skills Test) as given below.

Accordingly, Screening test was held for Stage-I and II on 18.11.2018 and Stage-III was held from 21.01.2019 to 25.01.2019. The number of applications received, screened in and the number of candidates appeared in Stage-I / II / III are given below.

1. Select panel is prepared in the order of merit.
