**RESULT OF THE RECRUITMENT PROCESS FOR THE POST OF UPPER DIVISION CLERK IN THE LEVEL 4 OF THE PAY MATRIX IN DIRECTORATE OF CONSTRUCTION, SERVICES & ESTATE MANAGEMENT AGAINST ADVERTISEMENT NO. DCSEM/01/2018.**

An advertisement was issued for the post of Upper Division Clerk for 6 posts (UR-3 / OBC-3) vide Advt. No. DCSEM/01/2018. Selection to the post consists of the following stages.

Stage I	Objective test covering 1. General English 2. General Knowledge 3. General Intelligence & Reasoning 4. Quantitative Aptitude (Arithmetic).
Stage II	English language and comprehension (Descriptive written test)

Stage I was only qualifying exam / screening test to shortlist candidates for Stage II. General candidates and candidates belonging to SC/ST category who scored 50% and above marks, and OBC candidates who scored 40% and above marks were called for Stage-II.

During the process of evaluation of answer sheets of Stage-I, it was found that the question No. 6 (e) was framed wrongly. Marks assigned to that question is 2 marks. Hence the question is omitted for evaluation and total marks extrapolated to 100.

The criteria for empanelment was marks obtained in Stage-II. The merit positions of candidates scoring identical marks in Stage-II have been decided after sorting their marks in Stage-I.

**Note:**

1. The selected candidates should note that the panel is provisional and does not confer on him/her any right to appointment unless he/she satisfies the Recruitment Norms as per the advertisement and pass the prescribed medical examination. If it is found that any candidate is not fulfilling the Recruitment Rules/Norms, his/her candidature is liable to be terminated/cancelled at any time.
2. The wait list shall be operated only in the event of occurrence of a vacancy caused by non-joining of the candidate from the select list within the stipulated time allowed for joining the post or where a candidate joins the post but resigns or dies within a period of one year from the date of joining, if a fresh panel is not available by that time. Wait list shall however, not be operated beyond one year or after notifying any such recruitment whichever is earlier.
3. The appointments will be subject to availability of vacancies and other related Govt. orders (viz. satisfactory completion of verification of Character & Antecedents (C&A) and Caste and creamy layer status for OBC.
4. Records of the candidates not selected shall not be preserved beyond 6 months from the date of publication of select panel.
