CIRCULAR

Sub: Guidelines for owners of pet animals in Anushaktinagar/other DAE colonies in Mumbai.

Pet animal owners residing in Anushaktinagar/other DAE colonies in Mumbai are requested to kindly abide by the following guidelines so as to avoid inconvenience to other residents:


1. Pet owners should ensure that their pets are healthy and clean and vaccinated. They are requested to inform Enforcement Section, DCSEM regarding pet animals at home along with valid licence issued by MCGM to e-mail ID strayanimals@dcsem.gov.in in the enclosed format.
2. They are advised to leash their pets while taking them for walks in public places and also in common areas so as to avoid inconvenience to other allottees and passersby. They are also advised not to allow pets to stray on passages and staircases.
3. Pet owners and caretakers while taking their pets out for stroll at public places, roads or footpaths allow them to defecate in public place, thereby causing unhealthy and unhygienic conditions. Pet owners are, therefore, requested to clean up when the pet defecates in public premises for maintaining clean and healthy environment in the colony. The Municipal Corporation of Greater Mumbai (MCGM) has made it compulsory for pet owners to carry shit lifter equipment while walking with their pets. As per MCGM's Cleanliness & Sanitation Byelaws - 2006, it is the responsibility of the owner of any pet animal to promptly scoop/clean up any litter created by pet animals on the street or any public place, and take adequate steps for the proper disposal of such waste. On failing to do so, pet owners will have to face a fine of Rs.500/- as specified in the Byelaws.
4. It would be the responsibility of the owner to ensure that their pet is not a nuisance for others in the housing colonies.

All pet animal owners are requested to kindly cooperate for ensuring a clean, healthy, and co-existing environment in all DAE colonies.
