

**Salient features of the Direct Recruitment Process for filling up of the post of Assistant Security Officer/A in the Level 6 of the Pay Matrix in Directorate of Construction, Services & Estate Management against Advertisement No. DCSEM/01/2018.**

An Advertisement was issued for the post of Assistant Security Officer/A (ASO/A) (5 posts - UR Category) (Level-06 in Pay Matrix) in this Directorate.

2. The details of no. of applications received, Screened-in candidates appeared in Stage-I and Stage-II tests, etc. are given below:

3. The tests were held in two stages. Stage-I (Physical Test) was held from 3<sup>rd</sup> – 7<sup>th</sup> December, 2018 at PTAA facility, Anushaktinagar. The Candidates qualified in the physical test were called for Stage-II (Written test) on 13.01.2019 (Sunday) at HBNI, Anushaktinagar and the list of candidates called for Written Test was published on 17/12/2018 in DCSEM website. The Mark list of the candidates who appeared in the Stage-II (Written Test) was also published in the DCSEM website on 08/04/2019. Document verification of the first 10 candidates in the merit list is completed as per the requirement.

4. In terms of DAE Office Memorandum dated 20.07.2016, interview has been discontinued for recruitment to Group B (Non-Gazetted) and Group C categories of posts. Therefore, no interview was held for recruitment to the post of ASO/A, being a Group B (Non-Gazetted) post.

6. In the case of candidates having identical marks, their names have been placed in the select list in the order of their date of birth, whichever is earlier.

7. The wait list shall be operated only in the event of occurrence of a vacancy caused by non-joining of the candidate from the select list within the stipulated time allowed for joining the post or where a candidate joins the post but resigns or dies within a period of one year from the date of joining, if a fresh panel is not available by that time. Waiting list shall however, not be operated beyond one year or after notifying any such recruitment whichever is earlier.

8. The selected candidates should note that the panel is provisional and does not confer on him/her any right to appointment unless he/she satisfies the Recruitment Norms as per the advertisement and pass the prescribed medical examination. If it is found that any candidate is not fulfilling the Recruitment Rules/Norms, his/her candidature is liable to be terminated/cancelled at any time. While every care has been taken in preparing the result, this Directorate reserves the rights to rectify errors and omissions (if any).

9. Record of the candidates not selected shall not be preserved beyond 6 months from the date of publication of select list.
