

Salient features of the Direct Recruitment Process for filling up of the post of Driver (Ordinary Grade) in the Level 2 of the Pay Matrix in Directorate of Construction, Services & Estate Management against Advertisement No. DCSEM/01/2018.

Advertisement was issued for the post of Driver (Ordinary Grade) (2 posts - General category) in this Directorate on 05.05.2018 with closing date on 04.06.2018.

2. Examinations were held in two stages as given below.

Stage-I (Written Test) for selection to the post of Driver (Ordinary Grade) was held on 06.01.2019 (Sunday) from 1000 hours to 1200 hours at HBNI, Anushaktinagar. The result was announced on the same day evening. After declaration of results, documents of the qualified candidates were verified. These candidates were called for Stage-II (Driving test) on the next day i.e. 07.01.2019 (Monday).

Stage-II (Driving test) was held on 07.01.2019 from 0900 hours onwards in Anushaktinagar.

3. The details of no. of applications received, Screened-in candidates appeared in Stage-I and Stage-II examinations etc. are given below:

4. The criteria for qualifying in the Stage-I (Written test) was decided as 76% marks. 17 candidates were called for skill test. 2 candidates were screened out during document verification and 15 candidates have qualified for Stage-II test. Considering the nature of duties of the post i.e. driving light and heavy vehicles, it was decided to give weightage of 30% of marks obtained by the candidates in the Stage-I test and 70% of marks obtained in Stage-II test, for final selection of candidates.

6. Appointment of the candidates will be subject to production of Original Certificates regarding Educational Qualification, valid Driving Licence, Experience Certificate(s) issued by Universities/Institutions etc.

7. The wait list shall be operated only in the event of occurrence of a vacancy caused by non-joining of the candidate from the select list within the stipulated time allowed for joining the post or where a candidate joins the post but resigns or dies within a period of one year from the date of joining, if a fresh panel is not available by that time. Waiting list should however, not be operated beyond one year or after notifying any such recruitment whichever is earlier.
