

Salient features of the Direct Recruitment Process for filling up of the post of Scientific Assistant / B in the Level 6 of the Pay Matrix in Directorate of Construction, Services & Estate Management against Advertisement No. DCSEM/01/2018.

An advertisement was issued for the post of Scientific Assistant / B for 9 posts (UR-6 / SC-2 / OBC-1) in four disciplines, vide Advt. No. DCSEM/01/2018. As per the methodology for selection to the post, selection will be on the basis of performance in personal interview. The number of candidates to be called for interview were restricted by conducting a Screening Test of eligible candidates applying for the posts. Marks secured in Screening Test were not taken into account for the final selection.

Note:

1. The selected candidates should note that the panel is provisional and does not confer on him/her any right to appointment unless he/she satisfies the Recruitment Norms as per the advertisement and pass the prescribed medical examination. If it is found that any candidate is not fulfilling the Recruitment Rules/Norms, his/her candidature is liable to be terminated/cancelled at any time.

The wait list shall be operated only in the event of occurrence of a vacancy caused by non-joining of the candidate from the select list within the stipulated time allowed for joining the post or where a candidate joins the post but resigns or dies within a period of one year from the date of joining, if a fresh panel is not available by that time. Wait list shall however, not be operated beyond one year or after notifying any such recruitment whichever is earlier.
3. The appointments will be subject to availability of vacancies and other related Govt. orders (viz. satisfactory completion of verification of Character & Antecedents (C&A) and Caste and creamy layer status for OBC).
4. Records of the candidates not selected shall not be preserved beyond 6 months from the date of publication of select panel.
