

Directorate of Construction, Services & Estate Management, Mumbai**Salient features of the Direct Recruitment Process for filling up of the posts of Technical Officer/C in the Level 10 of the Pay Matrix in Directorate of Construction, Services & Estate Management against Advertisement No. DCSEM/01/2022.**

An advertisement was issued for 3 posts of Technical Officer/C in two disciplines (Civil / Mechanical), vide Advt. No. DCSEM/01/2022. Last date of receipt of applications was 29th April, 2022. Selection was on the basis of performance in personal interview.

The number of candidates to be called for interview were restricted by conducting a Screening Test on 24th September, 2022, of eligible candidates applying for the posts. Marks secured in Screening Test were not taken into account for the final selection. Interviews were conducted on 1st and 2nd December, 2022.

The number of candidates called for and attended screening test and called for and attended interview are given below.

SC candidates were interviewed with relaxed norms as per Government orders. As per the Government orders, empanelment of the candidates was done by the Selection Committee which consists of representatives of SC/ST/OBC, Female and Minority categories, along with one outside member.

Note:

1. Select panel is prepared in the order of merit.
2. The selected candidates should note that the panel is provisional and does not confer on him/her any right to appointment unless he/she satisfies the Recruitment Norms as per the advertisement and pass the prescribed medical examination. If it is found that any candidate is not fulfilling the Recruitment Rules/Norms, his/her candidature is liable to be terminated/cancelled at any time.
3. The wait list shall be operated only in the event of occurrence of a vacancy caused by non-joining of the candidate from the select list within the stipulated time allowed for joining the post or where a candidate joins the post but resigns or dies within a period of one year from the date of joining, if a fresh panel is not available by that time. Wait list shall however, not be operated beyond one year from the date of publication of panel on the DCSEM website.
4. The appointments will be subject to availability of vacancies and other related Govt. orders viz. satisfactory completion of verification of Character & Antecedents (C&A), Caste certificate and creamy layer status for OBC.
5. Records of the candidates not selected shall not be preserved beyond 6 months from the date of publication of select panel.
